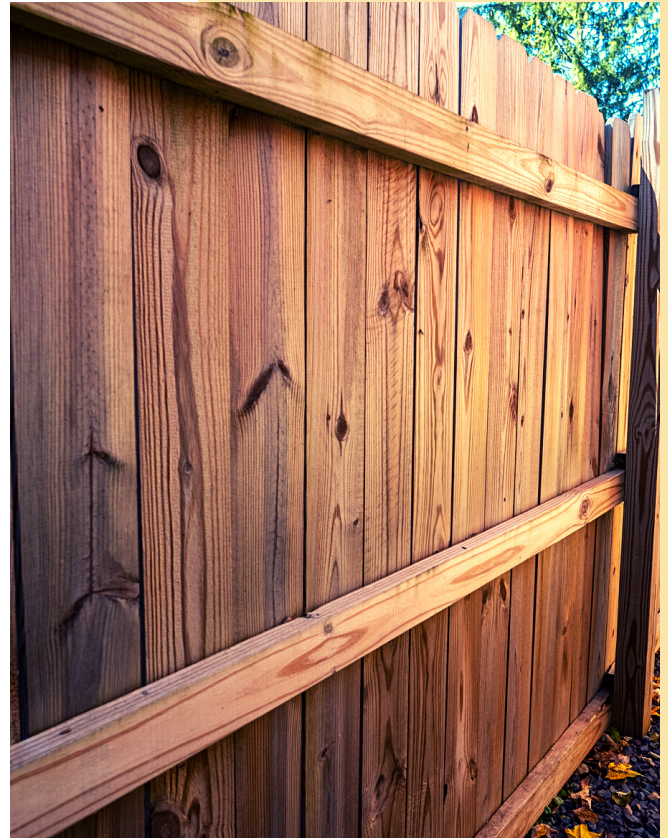


# REMINDERS
